- 5) Bid must be valid as above mention period after bid opening and must be accompanied by a bid security and scanned copy of the bid security in pdf format amounting the above mentioned. Bid Bond which shall be valid for **30 days beyond the validity period** of the bid.
- 6) Electronic bid must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 Hours** on **2077/06/13**. Bids received after this deadline will be rejected.
- 7) The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 hrs Noon** on **2077/06/13** at the Office of **Jagannath Rural Municipality, Juddi, Bajura.**
- 8) If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered as the last day. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
